re MRS SHANNON

Sir,

We beg to refer you to our letter of the 23rd instant informing you that we act for Mrs Shannon, the owner of premises Nos. 107, 108, and 109 South Circular Road and No. 57, Camden Street, and that damage had been done to these premises during the recent disturbances to the extent of £5. We beg to inform you that through a clerical error 57, Camden Street was included in this letter. The £5 damage was done entirely to the South Circular Road premises and the damage which was done to No. 57 Camden Street was much more extensive and comprises, damage to the roof, top front room, drawing-room, dining-room and to the corridors of the house and the damage to No. 57, Camden Street alone amounts to the sum of £12.13.0, and we have our Client's Contractor's estimate before us at the present moment.

We would be extremely obliged if you will rectify our letter of the 23rd instant and at the same time take a note of our claim in connection with No. 57, Camden Street,
