Referring to our claim which ^{was} you sent to Mr. Healy, we now beg to enclose certified copy of the Policy on these Premises which, as you will see, is in force until 25th December next.

CLAIM 15, D'OLIER ST. :- You will find all particulars as to this on the blue form, and if you require any further information perhaps you will let us know.

CLAIM 16, LOWER BRIDGE ST. (Hoarding) :- The size of this hoarding is 35 ft. high x 20 ft. wide with large painted sign on top. This Hoarding was built over a basement, and the amount we claim is what we estimate it would cost to replace it. We build all our hoardings ourselves, and if you require any further information, you can get the price of timber from any local firm so as to guide you in checking our estimate. But please remember that in rebuilding this hoarding it will require a great deal of timber owing to being built over a basement.
