I had an interview with the Applicant in this connection, who is most respectable. The Machine was Interests in the buildings burnt in the conflagration in Sackville Street during Easter week and was 8 months in use. The Bicycle was purchased from Kelly of Lower Abbey Street for the amount stated, and this I verified. I also obtained verification from the Claimant's employer. I find, however, that no allowance has been made for the period the Machine was in use, and though I am informed that same had been little used, I am quite satisfied that the sum of £7.7 will be very acceptable to the Claimant.
