

Interests in the buildings

I have gone into details with the Claimants, and while Messrs. Leckie put down the cost price at £12. 14. 5., the labels have had to be renewed by Messrs. James Walker & Co., at a cost of £24. 18. 9. I have procured and attached samples of the labels to the papers. Claimants always had a large stock of labels at their Printers' premises (which were completely burnt out) in order that they might from time to time have the wording "Bottled by " filled in, as the orders

from various clients came to hand.

The last item of claim - Knife - was Claimants' own property and was used for cutting the D.B.X. label (heart shaped) attached.

Under an Insurance contract of course the claim £24. 18. 9. would have to be passed to replace the loss. However, I have put down £20 as a reasonable figure which the Committee might deem it able figure which the Committee might deem it

advisable to pay.
