

Dear Sir,

In connection with the recent disturbances in Dublin, I wish to bring the following case under your notice with a view, if possible of obtaining some compensation for losses sustained as a result thereof.

Previous to the outbreak of the Rebellion I carried on business at the above address as Bootmaker & Repairer, but owing to incessant rifle fire etc., I was obliged to vacate my premises and seek shelter elsewhere.

During my absence the Military took possession of my shop and used same as a Mess Room, they, having to effect a forcible entry and upon my return and taking a list of my stock the following deficiencies and damage were found to exist viz:-

> 7 doz rubber heels @ 4/6. 1:11:6. @ 2/9. 11:0. 6 7:00 13 @ 3/ 7:6. 1 Patent fastener m/c 3:60 6 doz polish @ 90. 4:6. laces. @-9d. 4:6. Cut leather. 3:7:6. Sprigs, nails, etc. etc., 1: 5:0. Rent of shop whilst in possession of Military 1: 0:0. Customers boots taken. 17:6. Total £9:19:6.

In addition to the above I had to replace locks etc., broken which cost me 3/9d. so that the Grand Total of my losses amounts to \$10:3:3.

The foregoing truthfully represents my losses and to which fact I beg to subscribe my signature.
