but as everything has been burned, there is nothing to work on. I am not particularly impressed with the Applicant, and his estimate of loss is - I am inclined to think - inflated. No consideration can be given to his claim of £3. for Books of Account, as a Fire Policy does not as a rule cover same. In this latter connection he did not trouble himself to guard against ordinary risk of Fire.
