

Claim for Damages caused during the Disturbances on the 24th April, 1916, and following days. Dominich Rogan 13 Cabra Therines in the County do hereby solemnly and sincerely declare that on or about the 30 1916, damage was done to the undermentioned Property, namely :- * Totalor Crop damaged in Garden at sere of house 13 and such damage was occasioned to the best of my belief by ** Trenches having been dug across garden by Military And We further declare that the Property and Articles specified on the other side were so destroyed or damaged; that the Cost Price of same was as shown in each case; that at the time of the destruction or damage they were respectively of the Values specified under the head "Value of Property at time of Destruction or Damage"; and that, in consequence of such destruction or damage, claim is hereby made for the sums specified under the head "Amount Claimed"; that the Claim is made by me; and that no person is interested in the said property except; myself and that it is not insured by me or any other person, § except as follows, namely:—Company, Policy No....., Amount £... And I make this solemn Declaration conscientiously believing the same to be true, and by virtue of the provisions of the Statutory Declarations Act, 1835. Made and subscribed the 29 day of Bessel in the said City, County before me, a Justice of the Peace for the said -City County. Signature Claimant
