I have carefully looked into this claim. I have seen the Contractors that estimated for the repairs, and on visiting the premises and measuring up the work necessary, I am of opinion that the estimated cost is reasonable. Interests in the buildings I have, however, to draw attention to the fact that the building is occupied as a Butcher's Shop, and this is at variance with the description of the premises in the Policy. There is therefore a violation of Condition 2 of the Policy, and the Company could repudiate liability. I have also to draw attention to the further fact that the Policy is not in favour of Claimant.
