The neglect of these people and others to insure their property against the risk of fire is hardly to be excused. The Fire Policy on the D.B.C. would not cover their property, and if a fire occurred in the ordinary way they would have to bear their own loss. I have very carefully investigated each item of the claim, which is claimed for at cost.

Claim for Damages caused during the Disturbances on the 24th April, 1916, and following days. Premier Win that ....now residing at 19 Victoria Villas Clenterf in the City of Dublin Secretary of the Premis do hereby solemnly and sincerely declare that on or about the 24th day of April 1916, damage was done to the undermentioned Property, namely: -\* the club room of the Premier Whist Club in the premises 6 and 7 Lower Sackville and such damage was occasioned to the best of my belief by\*\* 6 and 7 Dower Sackville Street being destroyed by fire And We further declare that the Property and Articles specified on the other side were so destroyed or damaged; that the Cost Price of same was as shown in each case; that at the time of the destruction or damage they were respectively of the Values specified under the head "Value of Property at time of Destruction or Damage"; and that, in consequence of such destruction or damage, claim is hereby made for the sums specified under the head "Amount Claimed"; that the Claim is made by Provide Whist Club and that no person is interested in the said property except : the lower the of the Power flat of which I am Seen terry & Freakers and that it is not insured by me or any other person, § except as follows, namely: ....Company, Policy No....., Amount £... And I make this solemn Declaration conscientiously believing the same to be true, and by virtue of the provisions of the Statutory Declarations Act, 1835. Made and subscribed the Thirteenth day of Sheet Dublin in the said City, Gounty, before me, a Justice of the Peace for the said George Rijce County.
