Ke - the discrepancy in the amounto claimed, I beg to state that my first claim was sent in soon after the rebellion when I was greatly uppet, and I was unable at the time to think & remind myself

of all the articles that had been destroyed. Leveral receipts were mislaid on me & the claim was written by an incompetent person. I had occasion (of necessity) to fix up another workshop later on & during the fixing of same I reminded myself of various articles that had been omitted in the first Claim. Vaturally, when I received the official forms to fill in my claim, I took the opportunity to welade everything that I had omitted & I consider the later claim to be a true statement of my losses. I beg further to state that should your committee desire it I will produce all (or nearly all) the receipts of articles set out in the claim. Trusting, Sir, this explain-- ation will be deemed as satisfactory, I beg yours respectfully
