

Interests in the buildings

The Plate Glass has been replaced by the "Ocean" who were liable, and must therefore be eliminated from Claim. The upstairs glass would of course come under the Building Item. Claimant is the sole owner of the premises which were left to him under will by Mr. Langan, the former proprietor. Claimant had been assistant to Mr. Langan who died worth £200,000, and the Will was contested. I personally recollect probate being granted by the Court.

The damage to the building is not as serious as the claim sent forward would lead one to believe.
