Dear Sir,

In reply to your letter of the 25th inst. reporting on the claim which you have made for the loss of stock, I beg to say that from the invoice price you should allow a ten per cent. bonus to bring the goods down to cost price.

In addition to this however there should be added 22 per cent. for packing material and wages at this side and something in addition which you must settle for the unpacking and racking on your side. Then there is the carriage which to Ireland is very heavy. The percentage of carriage at your Branch is 5.46 but as this includes all the places in the United Kingdom which are near to as well as afar off, the carriage should be estimated at 7.5 to be somewhere near the mark for Ireland.

I think this information is what you require, but if not please wire me on Monday anything further you may wish to know.
