Our Clients, Messrs Goodsons Limited, of No. 42 Portland Street, Manchester, the above Claimants, have been forwarded a draft for £924. 16. 0. in part discharge of their claim herein. We understand that this amount has been paid in full discharge of portion of their claim amounting to £1228. 7. 4. being £455 the value of certain fittings, and £733. 7. 4. value of the Stock destroyed. This means that in respect of these claims our Clients will lose a sum of £303. 11. 4. and as they consider that their claim submitted was a perfectly fair and reasonable one, they feel aggrieved that they should have to bear this serious loss.
