There were in all three claims received for fish sent by rail to Amiens Street Station and not delivered. In the case of Mary Finglas inquiries made by the Committee's Inspector went to show that the fish was consumed by the military, and the claim was consequently admitted by the Committee. In the remaining cases (Mathew Murphy, No. 551 and P. J. Smith No. 747) it transpired that the fish went bad and had to be thrown out as unfit for human consumption. In the circumstances the loss became a consequential one and as such
