

We enclose you claim for damages herein in duplicate for panes of glass broken during the Rebellion in 41 Stephen's Green. The claim has been completed by Mr. R. R. Wade, who is the Receiver in the Minor Matter, under the Order of the Lord Chancellor, and he and Sir William Fry are the Trustees of the Will of the late Mr. Thomas G. Wade, the Father of the Minors, under which they derived the property. We have annexed to the claim the estimate dated the 12th ult. of Mr. W. C. McRae, the Contractor for replacing the glass; particulars of the Policy of Insurance issued by the Royal Exchange Assurance Corporation, and a duplicate of the last receipt for the premium.

We hope you will find everything in order.


