Interests in the buildings

This building is occupied on a yearly tenancy by Messrs. Kennedy, Drapers, Outfitters & Ready Made Clothiers. The glass is correctly enumerated, and was all broken by rifle shots, being only a few yards from Jacob's premises, which was the scene of much fighting. I have falled on Messrs. Sibthorpe who have replaced the glass, in regard to the prices which seem high, but owing to the difficulty of obtaining glass it could not be replaced less at the time. There was no salvage. Allowing, therefore, 5% off their account, the claim would work out at £32.6.0. There is no Plate Glass or Fire Insurance Policy.
