We have your circular intimation of I6th inst. in which you query as to why our claim covered by our letter of I3th inst. was not made within the prescribed period, namely, I2th August I9I6. In reply we respectfully mention in the first place the value of our claim was made by the Traffic Manager of the D. & S. E. Rly Co. Westland Row, Dublin. At the time of the Rising these empty Barrels were in the hands of the Railway Co. However, on the I2th September last they wrote us that they had submitted a claim to you, but had been advised that such a claim should be made by the Firm direct. This is the only explanation we can offer, but at the same time we mention without prejudice we hold the Railway Co. entirely responsible, as up to the time of the Rebellion the Packages had not been delivered to us.

Trusting to hear from you at your convenience that you are in a position to dispose of the claim.
