With reference to your letter of the 13th inst. directed to Mrs. Mary Burke of 34 Mount Pelier Hill, same has been handed to us to answer. We formulated the claim on behalf of this Lady for £25:11:0: and we must say that we are unable to follow how you arrive at the sum of £10 as compensation. Our client's property has been absolutely destroyed, save in respect of a sum of £2:16:6: and she will not be able to replace the articles for the sum of £10. We would ask you to communicate with the Assessor and let us know how the figure is arrived at.
