

Dear Sir,

In reply to your letter of the 4th instant 1 beg to say that on the 15th June, 1316, the Property Losses Committee was appointed to report to Government on claims for property lost or damaged in connection with the disturbances in Ireland in April-May 1316, and notices appeared in the press calling on all who had suffered loss to send in their claims to this office. The 17th August was fixed as the latest date for receiving intimation of claims.

As the Committee are now winding up their work they cannot accept any fresh claims. If, however, in the four cases
in which you are interested claims were lodged for hearing at
Quarter Sessions, and you will write to me to this effect at
once, giving the date of such lodgment, it will be seen
whether claims can now be entertained by the Committee.
