Sewing Machine Co. on the subject, and have ascertained that they are making a claim for the Machine along with a number of others. In the event of the Singer Co. getting paid by the Committee, they will either supply the Claimant with a new Machine or refund her the amount of the instalments paid (about 39/-)

I have seen the Superintendent of the Gas Co. in connection with the money which was robbed from the Gas Meter, and I have ascertained from him that they will not make any claim in this matter, but are holding the Claimant entirely responsible for the amount. I inspected the Gas Demand Note for the sum of 13/-.
